## Block Party & Grand Opening

This is an agreement by and between Metroport Chamber ("VENDEE") and VENDOR listed below (Vendor") for VENDOR to arrive and promote their business, product or service at The Taste! ("EVENT"). The undersigned VENDOR agrees to following terms presented below.

VENDOR agrees to appear at the EVENT located at 381 W. Byron Nelson Blvd. Roanoke, TX 76262 ("LOCATION") on May 6, 2021 to promote their business, product or service to those that are in attendance.

VENDOR agrees to pay \$150 for space at the EVENT. This fee may be waived upon approval of VENDEE for product or service provided by VENDOR to attendees. 150+ attendees expected. VENDOR can bring additional attendees to assist with serving those at the EVENT.

VENDOR agrees to appear at LOCATION set to serve by **3:30 PM**. If VENDOR may be late, they must notify a member of the VENDEE staff as soon as possible. Contact numbers will be provided. VENDOR can start to take down and clean up their station no earlier than **8:00 PM**. VENDEE will evaluate and advise if this time should change.

VENDOR agrees that VENDEE is not responsible for any loss, stolen, or misplaced products at the EVENT. VENDOR has complete and sole responsibility for their products.

VENDOR agrees that the exhibitor space fee payment of \$150 may be waived as long as the approved product/service is provided to EVENT attendees. VENDOR must provide their own table for set up/ display. Display area is 10'x10'. VENDEE does not guarantee sale of products and are not obligated to ensure that VENDOR recoups table fee through sale of products or services.

VENDOR agrees that this shall be a binding contract, and all terms have been included here. Any modifications made to this contract must be in writing and signed by both parties in order to be enforceable.
